## **Rules of Adoption / POLICY**

1. All animals adopted MUST be **spayed/neutered** & stay up to date on all vaccines for their entire lifespan (includes **heart worm preventative for the lifespan of the canines**)
2. **ALL ADOPTERS ARE REQUIRED TO TAKE NEW PET TO OWN VET WITHIN 7 DAYS-THEN FAX PROOF OF PURCHASED (6 MONTH OR 12 MONTH) CANINE HEART-WORM PREVENTATIVE TO RESCUE.**
3. Be financially able to provide for the needs of the animal(s).
4. Have adequate time and facilities to care for the animal(s).
5. Have the consent of all adults residing in the household and be at least **21** years of age.
6. Be aware that few animals are perfect; be prepared to give PET(S) time to adjust/transition into its new environment.
7. This IS AN ADOPTION; we reserve the right to postpone or refuse any adoption that is not in the best interest of any animal.

The Adopter shall take the animal to veterinarian within seven (7) days of the date of this Agreement for a checkup, shots, and medication recommended by the veterinarian as well as immediately purchasing monthly heart-worm preventative – **YOU ARE REQUIRED TO EMAIL OR FAX (WITHIN 7 DAYS) PROOF OF PURCHASE OF A 6 MONTH OR 12 MONTH SUPPLY OF HEART WORM PREVENTATIVE TO RESCUE (FOR CANINES ONLY)**. HWHAR makes no representations or warranties as to the breeding, health, welfare or behavior of the animal. Adopter shall provide the animal with necessary veterinary care upon sickness, disease, or injury, and shall take it to a veterinarian at least once a year for an annual health examination, bloodwork and routine vaccinations-including Heart-Worm Preventative. **Adopter shall keep all pets in the home. Dogs must be on heart-worm preventative for the life span of the animal.**

**SPAY/NEUTER:** If not already spayed/neutered, Adopter shall have the animal spayed/neutered no later than ninety (90) days from the date of this Agreement-or-when pet is of proper age (6 months of age). \*Spay/Neuter is included in the adoption fee/donation. In order to have your new pet spayed/neutered **Contact us via email only [info@hwhanimalrescue.com](mailto:info@hwhanimalrescue.com)**. We will schedule/pre-pay for spay/neuter. Note: \*This will only be done at a location of the rescue's choosing. If adopter chooses to take pet to alternate vet, then cost of spay/neuter will be at adopters own expense (We do not reimburse). If adopter makes own appointment at a rescue approved clinic, rescue will not cover the cost of surgery. **Please note that the location of rescue selected clinic is subject to change. And any Changes or Cancellations must only be done by Rescue.**

Adopter shall provide animal with humane care; maintain in accordance with all current/future state, county, municipal laws and ordinances where Adopter resides (animal shall reside at the Adopter's address). The Adopter must provide a collar and identification tag for animal to wear at all times; provide food, water, shelter, veterinary treatment throughout its lifetime.

The Adopter shall provide animal with fully fenced yard or other humane means of exercise. The animal shall not be kept constantly chained or left outside without human supervision. The Adopter shall keep the animal as a household pet and not use pet for breeding or exclusively as a guard dog; adopter never will leave the dog unattended in a car.

Adopter understands that animals are unpredictable. Therefore, waive and release all claims, past, present, and future, against HWHAR, its officers and staff, for any damages and/or injuries to persons or property which arise from ownership of this animal.

The Adopter agrees that it is the Adopter's responsibility to accept and adopt the animal "As-Is". The adopter understands that HWHAR and its representatives have limited information regarding the health, temperament or habits of the animal adopted. HWHAR will not provide lifetime care for any adopted pet due to illness, breeding, behavior, or any other reason.

HWHAR may make inquiries and/or examine adopted pet at any time. If rescue determines that the adopter is not providing adequate food, shelter, veterinary care or is otherwise in breach of any of obligations herein, rescue shall be entitled to take the adopted animal back and make arrangements for the dog's care and re-adoption – with no refund of fees given.

**If Adopter cannot keep adopted animal, Adopter shall notify HWHAR immediately.** The animal shall not be sold, transferred, relinquished or given to any individual or retail or wholesale establishment for the purpose of sale/resale to public or any research institution where medical experimentation or other practices take place. HWHAR shall be notified that the pet cannot be kept in original adopter's care immediately. **IF A PET IS RETURNED** and HWHAR has taken physical custody of animal(s) and assumes all present and future expenses of adopted animal, regardless of a signed relinquishment form, the adopter is forfeiting all current/future rights to said pet. Adopter also agrees to forfeit all amounts paid to Half-Way Home Animal Rescue should a breach of the Adoption Contract occur. Any FEES already paid to HWHAR will be CONSIDERED A DONATION to the rescue, and the **Adoption Fee WILL NOT BE REFUNDED**. If any fees, including but not limited to attorney fees, court costs, transportation/gas fees, are incurred to recover the pet, the costs shall be the burden of the adopter and legal action can be pursued by Half-Way Home Animal Rescue to recoup any additional costs. ALL PETS Returned (must be up to date w/proof) on all vaccines & heart worm prevention.

I declare that the information I have provided in this application is complete and correct. I further declare that I have read and understand the entirety of this contract and that I am financially and physically able to care for a rescued pet. I understand that proper food and veterinarian care may be costly, and I am able and willing to meet the needs of my adoptive pet. **I understand that I am adopting this pet "As-Is" – that there is no guarantee of the pet's health, breeding or behavior and all future care is at my own (adopters) expense.** I understand the requirements and grant permission for Home Checks at random both prior to and following adoption. I submit that if the Adoption Application or the Home Check reveals falsification or misrepresentation of any facts on my part, HWHAR reserves the right to either refuse adoption or to nullify the adoption and reclaim said pet from my premises, without reimbursement of the adoption donation. I release Half-Way Home Animal Rescue from any liabilities I may incur from the adoption process. If I am adopting a feline – I agree to not 'declaw' – If I do, I understand that the feline will be removed from my care and relinquished back to HWHAR at any time and no refund will be given.
